Subject: Retraction of the EOL announcement dated September 1, 2023, of the Obsolescence of Honeywell Sensing & Safety Technologies' E-Stop & Push Pull Product Lines

Per Honeywell's retirement notice dated September 1, 2023, Honeywell had made the initial EOL decisions for its Push Pull & E-Stop product lines due to declining volumes and near-term impact from higher cost to serve. Since the EOL announcement, Honeywell has received feedback from customers on their long-term commitments for the Push Pull & E-Stop product lines and has made the decision to continue serve our customers with these products.
