### Notification to Generate Intel® FPGA JESD204C-FTILE IP license in Quartus v23.2 and later.

---

#### Description:

Intel is notifying customers who are holding an active JESD204C license and are using Quartus v23.1 or earlier that they may need to generate a separate JESD204C-FTILE license file when upgrading to a newer version of Quartus. Customers with active JESD204C licenses can login to the [Self Service Licensing Center \(SSLC\)](#) to generate the new license file for Quartus 23.2 and later, if using / planning to use JESD204C-FTILE IP.

Intel recommends that customers with active licenses for the following OPNs to generate a separate JESD204C-FTILE license file when upgrading to Quartus v23.2 and later. If customers experience challenges generating the IP in SSLC, please reach out to the local Intel representative.
