Due to the discontinuation of services from a critical supplier, NXP Semiconductors is requesting an immediate response from customers purchasing the MMRF5014HR5.

To ensure our ability to order the quantities of essential components needed for an uninterrupted supply of devices, NXP is requiring that orders for the MMRF5014HR5 to support customer needs through 2025, are placed by March 22, 2024.

Since this will require the acquisition and maintenance of inventory, these orders will need to be non-cancellable and non-returnable (NCNR).

A replacement for the MMRF5014HR5 is scheduled with engineering samples expected in Q3, 2024.
