- As a valued customer, Molex is notifying you we are continuing our manufacturing footprint optimization and production consolidation process. This consolidation will create further production synergy around similar type products, manufacturing processes, and customer market segments.
- Starting in June 2024, Molex will begin transferring injection molds for finished goods from our Lincoln, Nebraska plant to our Bangalore, India plant. Our priority is ensuring continuity of supply during the transfer period.
- If your product is not sourced from Lincoln, NE USA, you are not impacted by this transfer.

## PCN DETAILS

- Some molded housings are considered finished goods (FG's) requiring no further processing or value add prior to being sold and shipped directly to our customers. Shipments of injection molds for these FG's will starting June 2024 and be completed in July 2024.
- Only injection molds are being transferred. No molding presses or other auxiliary equipment is being transferred.
- No resin supplier changes are being made. Resin will continue to be sourced from the same supplier however the manufacturing location of the resin may change to maintain or improve local sourcing service levels.
- Packaging item will be localized, there won't be any DU & MLQ impact.
- **Product Impact** – no change to form, fit or function.
- **Molex part numbers impacted** – see attached list in PCN.
